#### Do you accept donations for senior nutrition?

Seniors age 60 plus or a spouse of any age are eligible for Catholic Charities Senior Nutrition Program. The suggested donation from participants is \$5.00 per meal. Meal cost is supplemented by funding received through the Agency on Aging of Northeastern Illinois and Catholic Charities. The total cost per meal including administration is \$11.00. Therefore, your donation helps us in our efforts to maintain this beneficial program. No one is ever denied a meal due to inability or unwillingness to make a donation.

**Volunteers** are always needed for the delivery of home delivered meals to program customers. Not only will volunteering for this program enrich your life, but will also enable the homebound to maintain their independence.

### What are Home Delivered Meals/Meals-On-Wheels?

The Home Delivered Meals Program is designed to provide a daily hot nutritious meal for homebound persons age 60 years or better. Each delicious, hot meal meets or exceeds one-third of the Dietary Reference Intake (DRI) for persons age 60 years and above and all menus are approved by a Registered Dietician.

#### What if I can't eat the food?

Each client is sent a daily menu by the first of the month. If you are unable to eat a particular meal for medical or religious reasons, notify your site coordinator at least 2 days prior and a substitute frozen entrée will be sent. If you prefer to cancel a meal, please call the site coordinator at least 2 delivery days ahead of time and the cancelled meals will not be shown on your donation letter for the month.

#### How are the Meals Delivered?

Home Delivered Meals are delivered by volunteers and staff to registered clients daily, Monday through Friday. For Holidays when our sites are closed, a frozen meal or boxed meal is delivered so that the senior will not miss the meal. While delivering the meals, our dedicated staff and volunteers also provide well-being checks to this often fragile and at risk population.

#### How do I sign up? How much does it

**cost?** Each new participant must participate in a comprehensive assessment. Each month, a donation letter will be sent to each participant indicating the number of meals delivered to them that month. It is important to note that no customer is ever denied a meal due to their inability or unwillingness to make a donation towards the cost of their meal.

#### What if I have a Doctor's appointment?

If you have an appointment and will not be home to accept the meal, let the site coordinator know at least two days ahead of time and your meal will be cancelled for that day.

#### How is the program supported?

The Home Delivered Meals program is supported by Catholic Charities of the Archdiocese of Chicago, the Agency on Aging of Northeastern Illinois, Customer Donations, State and Local Governments, and various fund raising endeavors.

#### Where is the food delivered from?

Home Delivered Meals are available for delivery throughout all of McHenry County, IL.
