Whereas, the Township Board of Grafton Township has the authority to pass a tax levy for the tax year 2011, collectible in 2012, and

Whereas, the Township Board has determined that it is appropriate to levy the sums in the document attached hereto as Exhibit A upon all property subject to taxation within Grafton Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with law for the General Town Fund, Public assistance fund and Insurance fund for the year 2012. McHenry County, Illinois, for the tax year 2011, collectable in 2012.

BE IT ORDAINED by the Board of Trustees of Grafton Township, McHenry County, Illinois, as follows:

SECTION 1: That the sum of One Million Seventy Thousand, Six Hundred Thirty Seven Dollars (\$ 1,070,637.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund

Social Security Fund

Insurance Fund

Illinois Municipal Retirement Fund

for the year 2012.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
